In enclosing reference No.MAKAUT/1R-05/2018 dated 02.05.18 received from MAKAUT, West Bengal the undersigned is directed to say that the Registrar, MAKAUT has informed that Garden High International School are running without obtaining permission / NOC / Approval of the State Government (Department in School Education) / UGC / MHRD,Gol / MEA,Gol. The School has got affiliation letters (through courier service) from Pearson Education Ltd. / Cambridge International Examinations / Northwest Accreditation Commission, USA.

This Department has got another letter from MAKAUT, West Bengal vide reference No.MAKAUT/1C-05/18 Part I /01 dated 23.05.18 stating that Few Colleges like "ICARIUS College Technology & Management" / "Don Bosco Academy - College of Management & Technology and Traditional Education" / "Emcons Business Academy" and "Siliguri Global Engineering Institute" are running in the State beyond the permission/NOC/approval of the State Government / UGC / MHRD / AICTE / Distance Education Council (DEC) etc.

Such Colleges have got affiliation from Acharya Nagarjuna University / Swami Vivekananda University / Jodhpur National University etc. by violating State Territorial Jurisdiction.

Under the above circumstances the MAKAUT has sought clarification from this department about the status of the above School / Colleges- particularly, the question of validity of the certificate issued by the respective authorities of the School & Colleges in question.

The Undersigned is further directed to request you to kindly look into the matter with priority as to ensure a suitable reply to the Registrar, MAKAUT in this regard immediately. If necessary, valued opinion of the Legal / Law Cell attached to this Department may be obtained in this regard. It will be appreciated if a suitable reply goes to MAKAUT within one week.
